Your above signature indicates that you have read, understand and agree to the Terms of Registration which includes, but is not limited to, all terms relating to tuition and delinquent accounts, liability waiver and the publications release. Signer agrees to assume full responsibility for all payments and fees. Failure to comply with the terms of registration constitutes a material breach and is grounds for termination of service at the option of Tucson Country Day School. Your signature certifies that the information provided is accurate to the best of your knowledge. This agreement constitutes the full and final understanding of the parties.

**TERMS OF REGISTRATION:** *\*Please read before signing agreement.*

**TUITION/BILLING:** WE BILL MONTHLY. TUITION IS DUE IN ADVANCE ON THE 1<sup>ST</sup> MONDAY OF EACH MONTH (Please note that some months have up to 5 billing weeks). A late fee of \$10.00 will apply if payment is received after 6:00 p.m. of the following Friday, and the child will be removed from the program until the balance is paid in full. Ask about Tuition Express if you wish to sign-up for automatic WEEKLY payments. Forms are available in the office. We gladly accept Visa and MasterCard.

**HOLIDAYS:** Tuition will be discounted only when the entire TCDS campus is closed for 3 or more consecutive days due to a holiday. Please refer to the school calendar or parent handbook for these dates.

**VACATIONS ~ ILLNESS:** If your child is absent due to illness or vacation during the school year, full tuition is due for the time your child is not in school. If your child is ill or on vacation for two or more consecutive weeks, full tuition is due for the first week and half tuition for subsequent weeks.

**CHANGE IN SCHEDULE ~ WITHDRAWAL FROM PROGRAM:** You must provide the office with written notice of any changes in schedule or withdrawal from program at least one week prior to the effective date of change/withdrawal. You will be required to pay all fees for the program you are currently registered for until written notice is received in the office.



**KEEP READING! THERE'S MORE ON THE OTHER SIDE...**

**DAILY SIGN-IN/SIGN-OUT/ RELEASE OF YOUR CHILD:** Your child(ren) must be signed in and out with a 1<sup>st</sup> initial and complete last name by those persons 18 years of age or older, and whose names appear on the Emergency Contact Sheet. You must advise the Director or other designated person in charge, in writing, if any other person other than those listed is to pick up your child. TCDS employees may require proof of identification from any caller or any person arriving to pick up your child. A telephone authorization may be confirmed with the custodial parent at a previously designated phone number.

**LATE PICK-UP:** If your child remains past the time the program ends, an additional fee of \$10.00 per fifteen (15) minutes or any portion of a fifteen (15) period will be charged. If there are multiple children, the fee will be assessed to each child. If your child remains past the time the program ends continuously, you will be advised to find care that better fits your schedule.

**DELINQUENT ACCOUNTS, RETURNED CHECKS, TUITION EXPRESS DECLINES:** If your account is continuously delinquent, you will be asked to withdraw your child(ren) from the program. A \$25.00 processing fee will be charged for any returned checks (this includes Tuition Express credit card and account withdrawals). If 2 checks are returned during one school year, all future payments must be made via cash or money order for 12 months. You will be responsible for payment of all costs involved including reasonable attorney fees if your account is sent to collections.

**REMOVAL FROM PROGRAM:** If your child is removed or withdrawn from the program for any reason, there is no guarantee a space will be available for your child later. \*If we determine that we are unable to provide the services to meet the needs of your child without jeopardizing the quality of care provided to other children, you may be asked to withdraw your child.

**FAMILY DISCOUNT:** There is a 10% discount for additional children in a family with a child enrolled in 5 full days of Pre-School or Pre-Kindergarten. The discount applies only to weekly tuition, not to special program fees.

**SPECIAL PROGRAMS FEES:** Field trips and optional programs may be offered. Most of these programs require fees in addition to regular tuition. Those fees are payable by the first day of the program.

**TRANSPORTATION:** Parents are responsible for providing transportation to and from TCDS. Transportation is only provided for authorized field trips.

**PARKING LOT SAFETY: *Please, please, please... Watch for little ones at all times!*** Observe all traffic related signs. Do not park your car in the loading/unloading zone located in front of the school. This is for loading and unloading only. Please observe all safety rules in our parking lot.

**DISCIPLINE:** Teaching children to respect others and be responsible for their actions are essential ingredients in our philosophy. We aim to create an environment that provides children an opportunity to grow and have fun with age appropriate activities set within consistent limits. Choices, redirection, positive reinforcement and logical consequences including time-out and parent conferences are all ways we strive to help children grow and learn within our limits.

**PUBLICATIONS RELEASE:** Tucson Country Day School may use photographs, reproductions and/or any sound recordings of my child. Such use would be limited to advertising and publicity for purposes of promotion the school.

**MEDICATION:** Tucson Country Day School may NOT administer over-the-counter drugs. A designated employee may administer properly labeled prescription medications if authorized in the required format on a daily basis. The school administrators or Health Clerk may apply first-aid, secure medical aid and/or ambulance service in case the parent or guardian cannot be reached.

**ILLNESS:** Your child will be sent home if he/she has a fever, is vomiting or has diarrhea. The child needs to be picked up by an authorized adult as soon as possible in the event of the above symptoms. Your child needs to be symptom free for twenty-four (24) hours before he/she may return to school. If your child has been exposed to a contagious disease, you must notify the school director or Health Clerk

**FIELD TRIPS:** Supervised field trips may be scheduled to local areas of interest. Your signature below authorizes TCDS to take your child on all field trips. In addition, you will be responsible to sign an authorization form on the day of the field trip.

**SPECIAL NEEDS CHILDREN:** If your child has any special needs, please set up an appointment with the school director. Your child will be enrolled once it is determined that TCDS can fully meet his/her needs.

**SWIMMING:** Your signature authorizes your child to swim at TCDS throughout the school year and summer camp.

**SUN SCREEN:** Your signature authorizes counselors/staff at TCDS to assist your child in applying sunscreen.

**LOST OR STOLEN ITEMS:** Tucson Country Day School is not responsible for any personal items that are lost or stolen.
